Slip, trip, fall	Possible	Minor	LOW	1.Participants may slip, trip or fall when accessing the tower ladder. 2.Participants might slip, trip or fall if running alongside the participant	1.Ensure no out of the ordinary tripping hazards are present at the beginning of each session 2.Proper instruction and guidance must be given on how to climb the ladder safely. 3. Warning given for loose rock if running alongside the participant.	LOW
Hand Injury	Unlikely	Moderate	LOW	Participant reaches up and grabs the pulley or cable and gets their hand caught between the two.	1 Instruct participant to hold the loose rope with one hand and the back up lanyard with the other.	LOW
Blow	Possible	Minor	LOW	Non Participant in the pathway of moving fox	1 Enforce the rule that no one is permitted in the line of the fox when it is moving.	LOW
Entanglement	Unlikely	Minor	LOW	Participant gets their leg caught in the excess rope used for the descent.	1 Instruct participants to hold the rope until instructed to drop it. 2 Ensure participant is not entangled before permitting to descend.	LOW
Weather	Likely	Minor	LOW	Participants do not wear appropriate clothing or practice sun smart strategies.	Slip Slop Slap and wearing appropriate clothing for the conditions	LOW
Snake bite	Rare	Critical	LOW	1.Participants may be bitten by a snake if unaware of surroundings while moving through the course	1.Ensure participants are aware of what to do if a snake is sighted 2.Define boundaries 3.Wear closed toe footwear 4.Participants and leaders are aware of first-aid kit locations 5.Participants or leaders have suitable form of communication	LOW
Fall	Possible	Moderate	MEDIUM	Participant releases the handle too quickly and does not lock it off before they hit the ground.	1. Participants are shown the device at the briefing to familiarise them with the device. 2. Teacher or support leader holds rope upon descent. Participant also holds rope below hip.	LOW
Rope Burn	Low	Minor	LOW	Participant or leader burns their hand on rope if the descent is too quick.	Wear gloves	LOW

FLYING FOX - WILKIN

Blow	Unlikely	Minor	LOW	The device sits in front of the face but at a little distance. Future purchase of new harnesses lowers the position of the device.	Inform participant to be aware of it and lean back. Participant will always be wearing a helmet.	LOW
Scrape or pinch	Unlikely	Minor	LOW	Participant gets their hand caught between handle and body of the device.	<ol style="list-style-type: none"> 1. Instructor demonstrates the correct use of the device. 2. Allow the participant to feel the rotation of the handle before it is used in the descent. 	LOW
Accidental release	Possible	Minor	LOW	If the Participant accidentally pulls the handle around to begin descent whilst riding the Flying Fox, they could fall suddenly onto the back up strop	1. Instructor must ENSURE the handle is in the STANDBY position before they leave the platform.	LOW

Health and Safety	Injury treatable in workplace (First aid)	Minor injury requiring professional medical attention or lost time from workplace	Injury requiring hospitalisation	Major Injury requiring prolonged hospitalisation and rehabilitation.	Injury causing significant permanent disability or death

Likelihood	Definition
Almost certain	Is expected to occur; almost inevitable
Likely	Will occur in most circumstances; not surprising if it happens
Possible	Possible or likely to occur in some circumstance
Unlikely	Could occur in some circumstances; surprised if it happens
Rare	May occur only in rare or exceptional circumstances, but would be highly unexpected
